



Issue of shares

Danakali Limited (ASX: DNK / LSE: DNK) (**Danakali**, or the **Company**) confirms that it has issued 75,000 new fully paid shares to employees, constituting PDMRs, as detailed below, on the vesting of performance rights. In addition, a total of 15,000 performance rights have lapsed.

A completed Appendix 2A has been lodged together with this announcement.

Secondary Trading Exemption – s708A Notice

Total voting rights

The Company advises that it has, conditional on admission, allotted and issued 75,000 new fully paid ordinary shares of no par value in the Company (**Ordinary Shares**).

Application has been made to the UK Listing Authority for the admission of those 75,000 new Ordinary Shares to the Official List of the UK Listing Authority and to trading on the London Stock Exchange's Main Market for listed securities and it is expected that dealings will commence on 20 January 2020. The new Ordinary Shares will rank *pari passu* in all respects with the existing Ordinary Shares in issue.

Following admission, the Company will have in issue a total of 318,621,306 Ordinary Shares. The Company does not hold any Ordinary Shares in treasury.

Therefore, the total number of voting rights in the Company is 318,621,306 which may be used by shareholders or other persons as the denominator for the calculations by which they will determine if they are required to notify their interest in, or a change to their interest in, the Company under the FCA's Disclosure Guidance and Transparency Rules.

The Company has received notification from persons discharging managerial responsibilities (**PDMR**) and persons closely associated with them (**PCA**) with respect to 75,000 fully paid ordinary shares issued by the Company on the vesting of performance rights.
